## “Keep It Going”

### Understanding Between The CRC and Its Ambassadors For Project Support

We congratulate you and are delighted to let you know that you have been chosen to take part in the CRC Ambassadors Program. We are confident that you will do your best to represent the Center and its endeavors within your project, which we found worthy of our support. In addition, within 10-15 years of receiving our support, we would like you to either return the original amount of money that was invested (a maximum of \$3000) back to us or instead utilize it towards helping a cause that you believe in. It can be a project invested in helping your community or you can even give the money to EMIS so that they can help teach future generations of peacemakers. Whatever the case may be, we would like you to continue the cycle of helping others through showing your support just like we are showing our support in you now. To “keep it going” if you will (see section 8 for more details).

Keep in mind that the amount of money and duration of the project discussed in this agreement may be subject to change at any given point depending on any future circumstances that may apply. In case your project needs more financial support than what you have received from the Center, we encourage you to reach out to other organizations for support as well and collaborate with them in addition to us.

The purpose of this understanding is to regulate your interactions as an ambassador with the CRC throughout the duration of your project.

#### 1. Communication Between CRC & Ambassador

The Ambassador agrees to cooperate with the Center, report continuously on the progress of their project, and to make the best use of CRC support for both the benefit of the project and for the promotion of the Center's objectives.

The ambassador also agrees to participate in the Center's activities and to stay in contact.

#### 2. Commitment Duration

- a. Commitment Period for Project Execution.
- b. Commitment Period for Repayment of received support – up to 10-15 years from the date the Ambassador was given the support.

- c. I understand the Center's reimbursement plan of the support given to me, either back to the center itself in a number of years or furthered towards a cause sharing the same goals.

4. Ambassador's Rights

- c. The Ambassador is invited to take part in any activities offered by the Ambassador Center.

5. Ambassador's Responsibilities

- a. The Ambassador – agrees to initiate, develop, execute, and report on the project approved by the Center (see Appendix A) [Ambassador Application for Project Support from the Charney Center](#)
- b. The Ambassador agrees to submit an annual extensive report to the Center on the status of their project in the space of a template determined by the Center.
- b. The Ambassador agrees to indicate in any comments given to any other person or organization about their project that it was made possible due to collaborating with the Center (see Appendix B [Charney Resolution Center - Mission and Goals Document](#)).
- c. The Ambassador agrees to maintain close contact with the Center for Media Editing and Postings throughout the duration of their project.
- d. The Ambassador agrees to participate in two activities (see section 6) of the Center per year for at least 3 years.

6. Ambassador Selection Activities

Sharing information, writing articles, participating in and/or leading discussions/lectures/simulations. Offering support for a new ambassador, assisting with a specific event, and any other task the Ambassador thinks of that they believe will be acceptable to the Center.

7. In case of non-compliance

If the Ambassador fails to meet the expectations and commitment, the Center may transfer the support received to another Ambassador who has a different project in mind that has been approved by the Center.

8. How to Successfully Return the Center’s Support After the Completion of a Project

We wish to create a vast network of EMIS alumni and CRC Ambassadors all over the world in order to establish a system of collaboration where they help and support one another in order to better their communities. Within 10-15 years, the Ambassador will return the support they received according to its nominal value (without interest) in one of the following ways and with the approval of the Center.

- a. Giving back the support to the Center for the use of future Ambassadors’ projects.
- b. Donating it to EMIS so they can continue to thrive.
- c. Donating it to a non-profit organization of the Ambassador’s choice. The money can also be used by the Ambassador to start a new organization that works within the same values of the Center.

9. Informed Consent

The Ambassador confirms in their signature below that they have thoroughly read the arrangements of this understanding and that they sign it with free and informed consent, having received all the information required for it and understanding its full implications.
